GOTS offers two label grades that textile products can carry: "organic" and "made with organic" signifying a minimum content of 95% and 70% organic fibres, respectively.

The remaining additional fibres used in combination must adhere to strict criteria.

Organic fibres are natural fibres grown without the use of synthetic pesticides, herbicides, fertilizers or GMOs (Genetically Modified Organisms), in accordance with the principles of organic agriculture. Organic agriculture is a holistic production management system that sustains the health of people, soils and ecosystems.



The cultivation of organic fibres is under the scope of organic farming standards, many of them defined by national governments. For organic fibre production, a certification to the IFOAM Family of Standards for the relevant scope of production

is required. The standards approved under the IFOAM family of standards are officially endorsed as organic and include both private and government regulations.

Apart from certified organic fibres, GOTS permits only certain materials as "additional fibres" for the remaining balance of the fibre composition.
